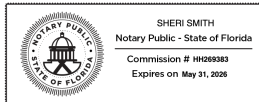

**NOTICE OF PULBIC HEARING**

The Town Council of the Town of Lowell, Lake County, Indiana, gives notice that it will conduct a public hearing on Monday, February 24, 2025, at 7:00 pm, or as soon thereafter as its agenda will permit, at the Town Hall, 501 E. Main Street, Lowell, Indiana 46356, on an Ordinance to amend sewer rates and charges for the Town's Sewer Utility. The proposed schedule of rates and charges is set forth as follows:

**Amendment of Sewer Rates and Charges effective upon passage:**

| Meter Size           | Monthly Rate |
|----------------------|--------------|
| 5/8 & 3/4 inch meter | \$67.00      |
| 1 inch meter         | \$167.50     |
| 1 1/4 inch meter     | \$268.00     |
| 1 1/2 inch meter     | \$335.00     |
| 2 inch meter         | \$536.00     |
| 3 inch meter         | \$1,005.00   |
| 4 inch meter         | \$1,675.50   |
| 6 inch meter         | \$3,350.00   |
