

ORDINANCE NO. 2015-29

AN AMENDED AND RESTATED ORDINANCE TO AMEND WATER RATES AND CHARGES FOR THE TOWN OF LOWELL WATER UTILITY

BE IT, AND IT IS HEREBY, ORDAINED by the Town Council (the "Council") of the Town of Lowell, Lake County, Indiana (the "Town") as follows:

Section 1. Ordinance 2015-29 adopted November 9, 2015, is amended and restated in its entirety by this Ordinance to correct a scrivener's error.

Section 2. Amendment of Water Rates, Charges and Fees. The Town Code of Ordinances shall be amended by deleting certain existing metered rates, minimum charges, tap-in fees and water service connection charges for water service set forth therein and replacing them with the following:


The fee schedules in the Town Code of Ordinances shall be revised to reflect the amended water rates and charges set forth above.




